#### C. ESTABLISH A QUORUM

It was determined that the attendance of Supervisors Eliot Goldstein, Garrett Dinsmore, and Jemaine Lemon constituted a quorum, and it was in order to proceed with the meeting.

Also in attendance were District Manager Michael McElligott of Special District Services, Inc. and General Counsel Jonathan Johnson of Hopping, Green & Sams, P.A., who attended by telephone.

#### F. APPROVAL OF MINUTES

1. June 12, 2023, Regular Board Meeting and Public Hearing

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE VERANDA COMMUNITY DEVELOPMENT DISTRICT AUTHORIZING AND ADOPTING AN AMENDED FINAL FISCAL YEAR 2022/2023 BUDGET ("AMENDED BUDGET") PURSUANT TO CHAPTER 189, FLORIDA STATUTES; AND PROVIDING AN EFFECTIVE DATE.

After a brief discussion, a **motion** was made by Mr. Goldstein, seconded by Mr. Lemon, and passed unanimously to adopt Resolution No. 2023-06, as presented.

#### 2. Consider and Approve 2-Year Renewal Option for Grau & Associates

Mr. McElligott explained that 3 years ago the Board approved a 3-year contract with a 2-year renewal option with Grau & Associates for audit services. Mr. McElligott presented the 2-year renewal to the Board and recommended approval.

After a brief discussion, a **motion** was then made by Mr. Goldstein, seconded by Mr. Lemon, and passed unanimously to approve the 2-year Grau & Associated contract renewal, as presented.
